Registrations

1. A registration form can be obtained from the MCEC office or sent via email upon request.
2. All communication between MCEC and Applicant will be via the Mehram, Parent or Guardian.
3. Only FULLY completed forms, with appropriate signatures will be accepted.
4. Completed forms can be handed into the MCEC office or emailed to enquiry@mcec.org.uk
5. For a registration to be accepted, you will be invited to a meeting to bring the following:
 - Passport or birth certificate
 - Address, e.g. a current utility bill, phone or bank statement
 - Proof of Education
 - Proof of employment (if employed)(please note these will be checked visually, copies will not be kept)

Contacting Potential Spouses/Profiles/Photos:

1. The mosque representative will try to match applicants and any potential matches will be notified via email.
2. If there is interest, the contact details will be passed to both parties who will take the responsibility to organise an appropriate meeting, outside of the MCEC.
3. The MCEC will not take responsibility to organise the meetings, or to be involved from this point onwards.
4. It is the Mehram's responsibility to notify the MCEC of the outcome of the meeting.
5. Details of profiles will be retained by the mosque. Only e-mail addresses and telephone numbers of potential suitors will be available to take away from the MCEC.
6. Any 'difficult' or fraudulent applicants will be removed from the files with immediate effect
